Biographies

Chuck Dotas is professor of music and coordinator of jazz studies at James Madison University, where he directs the JMU Jazz Ensemble. Dotas holds a B.M. from the University of Wisconsin at Green Bay, an M.M. from the Eastman School of Music and a D.A. from the University of Northern Colorado. He is well known as a composer and arranger, and his music is published through UNC Jazz Press, Walrus Music and Margun Music.

Marlon Foster taught instrumental music for the Harrisonburg City Public Schools system at the middle school level for 26 years. He has conducted and adjudicated workshops involving concert percussion, marching percussion and jazz band rhythm sections throughout Virginia. He has conducted many city, county and All-District concert and jazz honor bands at the middle school level. He was a member of the United States Air Force Band at Langley Air Force Base under the direction of Lowell E. Graham. He has performed with the Shenandoah Valley Choral Society, Rockbridge Symphony, Harrisonburg/Rockingham Concert Band and the Shenandoah Valley Bach Festival Orchestra. He continues to perform jazz with many local and regional jazz ensembles. Foster received his B.M.Ed. and M.M. from James Madison University.

Rupen R. Shah, Chief Deputy Commonwealth's Attorney for

Augusta County, was appointed by the Board of Governors of the Virginia State Bar Diversity Conference to serve and has worked diligently to further the goals of the Conference and to bring *Jazz 4 Justice* to the James Madison University stage. He has served as president of the Augusta County Bar Association and was recognized by the Virginia State Bar as the Local Bar

Leader of the Year in 2009. He has also served as president of Virginia State Bar's Diversity Conference. Shah has dedicated his career to protecting children. He founded the Valley Children's Center, a nonprofit agency that helps children who are the victims of trauma and abuse. Shah worked tirelessly to eliminate all-day waits for juvenile court cases to be heard. He also organized "So You're 18" programs for 2,000 high school seniors in Staunton, Waynesboro and Augusta County to teach them the rights and responsibilities that come with adulthood.

David A. Stringham, associate professor of music at James Madison University, has taught music to students of all ages in public, private, university and community settings. His research interests include composition, improvisation, music technology and lifelong musicianship. Stringham frequently presents at conferences and professional meetings; his research appears in several peer-reviewed journals. Stringham previously taught middle school and high school instrumental music in New York State, and holds degrees in music education from the Eastman School of Music (B.M. with highest distinction, M.M., Ph.D.).

Edward L. Weiner is the immediate past president of the Virginia State Bar. *Jazz 4 Justice* was Ed's brainchild 15 years ago at George Mason University. It has received national and state awards of recognition. Ed is very pleased to have *J4J* make its fifth appearance on the stage of the Forbes Center.



JMU and Sentara RMH Annouce New Dance and Physical Therapy Partnership

A new partnership between James Madison University and Sentara RMH will allow dance majors in the School of Theatre and Dance to receive training and treatment, much like athletic trainers provide for other sports at JMU.

Three years in the making, this program is the brainchild of Sarah Gosselin, a JMU alum who now works as a physical therapist at the brand new Sentara RMH Orthopedic Center. Gosselin graduated from JMU in 2008 with a double major in dance and pre-physical therapy.

According to Gosselin, the goal of this partnership is "to provide dancers with quick and easy access to a medical professional who specifically understands their needs and demands, and how best to treat them." As an undergraduate, Gosselin recalls feeling frustrated that dancers did not have anyone to go to who understood their injuries when they got hurt.

In terms of services, Gosselin will guest lecture in JMU dance classes this fall and provide injury screenings for all freshman dance majors in the spring. Students can also contact Gosselin directly with questions or set up an appointment. The collaboration will also provide students with internship opportunities in Sentara's new facility.

"The students lucky enough to intern with [Sarah] Gosselin at Sentara RMH have an amazing opportunity to shadow a working professional within a very specialized field," exclaims JMU dance coordinator and faculty member Kate Trammell.

Senior Kayla Bolton, who is majoring in dance and pre-physical therapy, says she is "more comfortable" obtaining treatment from Gosselin because she "understands the fundamentals of dance and can educate dancers on how to properly train and protect their bodies from future injuries."

The Sentara RMH Orthopedic Center houses imaging, orthopedic doctors and physical therapists all in one building. This coordinated

care allows orthopedic patients to "get everything they need to have done" in one central location, and makes Sentara's goal of providing as much education and treatment for the athletic population possible, says Gosselin.
